Please find attached the schedule for watershed sampling and associated periodic monitoring reports that will be implemented under the New Mexico Environment Department-approved "2007 Interim Facility-Wide Groundwater Monitoring Plan" (IFGMP). These dates are our best approximations of the schedule that fulfills the monitoring frequency set forth in the IFGMP. Although these are intended to be target start dates, the actual start date for sampling in any given watershed may vary subject to a variety of possible factors such as weather delays. The periodic monitoring report schedule is set at quarterly, as stated in the IFGMP, and each will include timely data from the preceding monitoring period.
