sored panel on realigning Transuranic Waste Disposal Priorities after the Las Conchas Fire, and also went very well.







Lee Bishop serves as the EM Legacy TRU Waste Program Manager for the Environmental Projects Office at the National Nuclear Security Administration's

Los Alamos Site Office (LASO). His primary responsibilities include providing administrative and technical leadership, direction, and programmatic oversight of TRU waste disposition in support of both EM and NNSA programs. Specifically, he ensures operational execution of TRU Waste processing in Area G including resolving program management issues; coordinating federal Integrated Project Teams (IPT), and managing waste disposition campaigns to accomplish

DOE strategic goals. A significant portion of his duties include interacting with Headquarters, other field elements, regulators, stakeholders, tribes, and the public.

Mr. Bishop's career spans over twenty-five years in the nuclear and environmental sectors. His prior DOE experience includes 17 years working as an environmental scientist in the Oak Ridge EM Program including serving as the technical lead for the DOE National Recycling Program, and working on the Yucca Mountain Project in site operations and serving as the Nevada Rail Environmental Impact Statement Manager.

Before coming to DOE, Mr. Bishop worked as a contractor in the Navy

and commercial nuclear fuel cycle: including fuel fabrication, reactor startup, refueling, decommissioning, remediation, and radioactive waste management. He received formal training and certification in health physics at Newport News Shipyard under the NAVSEA Program.

Mr. Bishop holds a BS Degree in Science from the Longwood University and has in-depth health physics experience including over 1000 hours of classroom training and previous qualification as a NAVSEA instructor. Mr. Bishop's projects have received two "White House Closing the Circle Awards" for Pollution Prevention.

The NNM CAB office staff would like to take this opportunity to thank the students for their hard work in creating these wonderful pieces they have allowed us to display in the office.





The NNMCAB recently submitted recommendation 2013-02 to DOE. Recommendation to Review Material Disposal Areas at LANL in Addition to Technical Area 54 for Risks Associated with Fires. The intent of 2013-02 is to ensure that that the appropriate level of review has been given to MDAs other then MDA G at LANL, that may have a similar risk in the event of wild fires. This recommendation was voted on and passed at the March 20th 2013 Board meeting, at the Marriott Pyramid North in Albuquerque.
