RCRA PERMIT ISSUES MEETING

JUNE 18, 1997

PROPOSED AGENDA

1. RD&D permit issues: Certifications for closure of the Packed Bed Reactor/Silent Discharge Treatment Unit and the Hydrothermal Processing Unit have been obtained. Preliminary sampling of existing components has been completed. Analytical results are pending.
2. TA-54 Closure Plans: ER Project is currently evaluating existing TA-54, Areas H and L closure plans. An information letter containing operating procedures, waste item inventories, and waste volumes for TA-54, Area J, is being developed for submittal to HRMB.
3. TA-50 Controlled Air Incinerator Closure: HEPA filter bank exhaust components and other scrap metal have been shipped for recycling to Scientific Ecology Group, Inc. Closure certification will move ahead upon receipt of SEG certificate of destruction.
4. Electrochemical Treatment Unit RD&D permit application: Request confirmation of Fall, 1997, schedule for permit application review by HRMB. DOE/LANL are evaluating the potential need to revise the permitting strategy for this unit by upgrading this request to a full treatment permit application.
5. Waste stream reclassification request: A request to reclassify 47 drums of STP LA-W904 soils with heavy metals was submitted to HRMB on October 18, 1996. A formal withdrawal of the request has been submitted to HRMB.
6. TA-14 Open Burn/Open Detonation Permit Application Notice of Deficiency: The TA-14 NOD was received by DOE/LAAO on June 12, 1997. Technical information requests are currently being reviewed by the operating groups and permitting staff. An extension petition may be necessary depending on the availability of the information requested.
7. Request project review status and discussion of potential HRMB concerns, if applicable:
 - TA-50-37 RAMROD permit modification
 - TA-14, 15, 36, and 39 permit modification
 - TA-54 TWISP approval
 - Draft Laboratory Implementing Requirement for vacating workspaces
