Subject: Submittal of Required Closure Documentation for Compliance
 Order No. HRM-97-02

The purpose of this letter is to provide required closure documentation for Compliance Order No. HRM-97-02, issued on March 24, 1997. This compliance order requires Los Alamos National Laboratory (LANL) to commence closure of two Research Development and Demonstration (RD&D) units under the requirements of the closure plans contained in their specific permits. LANL has worked closely with the Hazardous and Radioactive Materials Bureau (HRMB) staff to coordinate this effort. The following documents are enclosed:

1. The original signed certification statement from the proposed operator for the Packed-Bed Reactor/Silent Discharge Plasma Treatment Unit (PBR/SDPTU) indicating that the unit was never completely assembled to meet the design specifications contained in Permit No. NM0890010515-RDD.
2. The "Closure Certification Report for the TA-9 Hydrothermal Processing Unit" with the closure certification by a registered professional engineer, and signed certification statements from proposed operators of the Hydrothermal Processing Treatment Unit (HPTU) included as appendices to the report.
