Dear Mr. Gurule:

Of the total 2124 Potential Release Sites (PRS) at Los Alamos National Laboratory the Environmental Restoration (ER) Project has proposed 1,404 No Further Action (NFA) permit modification requests (through January 14, 1998). The Department of Energy reviews the NFA requests before submitting them to the Environmental Protection Agency (EPA) or the New Mexico Environment Department (NMED).

It is the understanding of the Northern New Mexico Citizens' Advisory Board that the government agencies, especially NMED, do not have the financial resources nor the staff to process the requests in a timely manner. Delays in the process may result in two problems:

1. The ER Project is forced to carry the subject PRS's on it's books, thus incurring additional costs.
2. It is expected that the agencies will deny some of the permit request based on any of several grounds, most notably that the site has not been restored to acceptable standards.

To help expedite the process the Northern New Mexico Citizens' Advisory Board requests that the ER Project formally notify the Board concurrent with DOE notification of future NFA permit requests. Such notification should include a brief description of the site, contaminant(s) and levels, type and level of risk assessment and NFA category. The Board will review the requests and make appropriate recommendations to the DOE, LANL, EPA and NMED. Inclusion and review by the Board should help expedite the restoration efforts at LANL.

Please advise when we can expect a response. Thank you.


Dear Board Members,

The Environmental Restoration Subcommittee of the Northern New Mexico Citizens' Advisory Board has reviewed the US DOE Office of Inspector General "Audit of Environmental Restoration at the Los Alamos National Laboratory" IG-0410". The audit recommended several actions targeted to improve the Environmental Restoration Program (ER) at Los Alamos National Laboratory (LANL). The DOE concurred with these recommendations. In particular the CAB is interested about the progress made by the Los Alamos Area Office and the LANL ER program towards satisfying these recommendations. The audit also raised several issues that the CAB would like to be informed about. Thus we request that the DOE, in concurrence with LANL, provide the following information :

1. Please describe the changes DOE made to the ER Program.
2. Does ER cost data exist for similar ER programs at other DOE facilities? If so, please provide comparable data.
3. Has DOE concluded anything from it's data validation studies?

The CAB recognizes that some of the deficiencies found by the Inspector General may have been due to changing, and conflicting, DOE, LANL or State of New Mexico requirements, definitions and accounting procedures. If this is the case then please describe the conflicts and efforts to eliminate these.

Please advise when we can expect a response. Thank you.

Environmental Restoration Committee

- Review LANL's No Further Action Sites
- Hold 4 Work Sessions on Risk-Based Analysis, Potential Release Sites, Canyons, Material Disposal Areas
- Travel to other Boards and Sites, e.g., Rocky Flats and Richland
- Review technical materials (e.g., text books, data from other facilities)
- Review and evaluate standards/criteria on 500 "No Further Action (NFA)" sites
- Review and evaluate remaining 600 sites
- Review and evaluate "Top 13" NMED sites
- Identify roadblocks to task completion
- How do NMED standards compare with DOE standards and EPA standards?
- How does DOE determine radionuclide standards?
- Identify communication standards. How can we facilitate an information exchange? How can we improve cooperation and coordination on work activities?
- LANL should send the Board the list of 2000+ "No Further Action" sites that they recommend for removal from the NFA list when they send this list to DOE in the December time frame. ER Committee will review LANL's recommendations and forward comments to DOE, NMED, the Secretary of Energy and the Governor of New Mexico urging expedited processing. CAB will publicize its comments and work to increase public pressure on state (NMED) to expedite the approval process.

Evaluation Criteria

6 Months - February 1999

- (1) The Committee has reviewed NFA standards and issued press release on findings.
- (2) The Committee has developed recommendation(s) re: NFA standards, prioritization of sites, and level of cleanup.
- (3) The Committee has reviewed and prioritized "Top 13" NMED sites.

1 Year - September 1999

- (1) The Committee has reviewed the criteria and standards on remaining 1,600 sites.
- (2) The Committee has worked with DOE and LANL on development of brochures, exhibits and reports addressing the evaluation of standards and prioritization of sites.

Monitoring/Surveillance Committee

- Hold Workshop/Seminars on Air, Water, Soil
- Identify and Analyze LANL's Documents and Data regarding Monitoring and

Surveillance

- Consult with Independent Consultants (EPA, NMED, Tribal, nongovernmental organizations like CCNS).
- Compare Sampling and Analysis Techniques with LANL, EPA, NMED, Tribal etc.
- Consult with Rocky Flats, Sandia, Hanford, Savannah River and other SSABs.
- Communicate with other Boards

Community Outreach

- Publicize the Work Plan
- Provide General Publicity for Meetings, Recommendations and Special Events
- Review Current Publicity Outlets and Develop New Strategy for Outreach to include: Pueblo newsletters, Eight Northern and Southern Tribal publications, Public Service Announcements, Newspapers, Environmental Papers, Television Shows and Radio Interviews, Spanish Language Announcements, Service Club Meetings, High School Students Special Projects
- Create Web site for Board and establish Links with Other Web Sites

- Jointly sponsor quarterly public meetings on Environmental Safety and Health related issues. Bob Prommel will follow up for CIO ESH

- The Environmental Restoration and Environmental Management Committee will coordinate and communicate "early and often" as they plan their meetings, workshops and field trips. Coordinate with Carmen Rodriguez in CIO

- Hot issues: Hold a public meeting in Pojoaque on possible well contamination, aquifer contamination, contaminated sediment at Cochiti Dam, has contamination migrated down to San Ildefonso, Nambe, San Juan, Española, or Santa Fe?
