Enclosed is a Public Notice regarding the proposed changes to the schedule in the Compliance Order on Consent between the New Mexico Environment Department, the US Department of Energy, and the Regents of the University of California. The DOE is an agency of the federal government, and is the owner of Los Alamos National Laboratory (LANL). University of California is the operator of LANL pursuant to a contract with DOE and are located at the following addresses: DOE, National Nuclear Security Administration, Los Alamos Site Office, 528, 35<sup>th</sup> Street, Los Alamos, NM 87544; and LANL/UC, P. The New Mexico Environment Department (NMED) is today releasing for public review and comment the proposed changes to the schedule in the March 1, 2005 Compliance Order (Order) on Consent for Los Alamos National Laboratory (LANL). The changes made to the schedule reflect extensions to submittal dates granted by NMED in response to requests from LANL and automatic time extension related to additional review time required by NMED in accordance with Section III.M.2 of the Order. NMED invites the public to comment on changes made to the Order, Tables XII-1 – Closure Milestone Schedule, Table XII-2 Schedule of Deliverables by Watershed, and Table XII-3 Schedule Deliverables by Calendar Year.

The Order requires the Department of Energy (DOE) and the Regents of the University of California (UC; or its successor) to conduct a laboratory-wide investigation and cleanup of contamination at LANL pursuant to schedules set forth in the Order. LANL covers approximately 40 square miles of federal land located on the Pajarito Plateau in Los Alamos County in north-central New Mexico, approximately 60 miles north-northeast of Albuquerque and 25 miles northwest of Santa Fe.

LANL is a research facility under the administration of the DOE and is operated by the UC. LANL is the site of research and development of the first atomic bomb. It has been in operation since the early 1940's. Throughout its history, LANL has conducted experimental research on the production of nuclear weapons and explosive materials, among other things. As a result of the research, LANL has generated and disposed of a variety of hazardous, radioactive and solid wastes on-site. Disposal activities at LANL started in the early 1940's and some continue to the present day. Hazardous and solid wastes that have been handled and disposed of at LANL include chlorinated and non-chlorinated solvents, high explosives, metals, polychlorinated biphenyls (PCB's), pesticides, perchlorate, nitrates and radionuclides.

**Availability of Information on the Proposed Changes to the Order:** The documents that comprise this action consist of the March 1, 2005 Compliance Order on Consent; the proposed Tables XII-1, XII-2, and XII-3 indicating the changes of the dates; and this Public Notice. 
