The Los Alamos National Laboratory (LANL) Environmental Restoration (ER) Project is planning to complete the sampling associated with Voluntary Corrective Action (VCA) field activities at Potential Release Sites (PRSs) 0-004, 0-029(a, b, and c), 0-030(b), 0-030(l), 0-030(m), and 0-033(b) on or about June 17 through July 12, 2002. These VCA activities consist of sampling soil and sediment in the vicinity of the 6th Street warehouses and an area of potential soil PCB contamination associated with power poles in Los Alamos Canyon.

Samples will be collected as shown in the table below.


