EXTENSION REQUEST FOR SUBMITTAL OF THE INVESTIGATION REPORT TWOMILE CANYON AGGREGATE AREA LOS ALAMOS NATIONAL LABORATORY EPA ID#NM0890010515 HWB-LANL-10-014

Dear Messrs. Rael and Graham:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Request for Extension to Submit the Investigation Report for Twomile Canyon Aggregate Area* dated November 17, 2011 and referenced by EP2011-0392.

The Permittees request the extension to submit the investigation report due to the need to focus efforts on shipment of aboveground transuranic (TRU) waste from Technical Area (TA) 54 to the Waste Isolation Pilot Plant, located in Eddy County, New Mexico. The need to remove TRU waste stored at TA-54 is aligned with Governor Martinez' policy to prioritize groundwater and surface water protection and accelerate the removal of TRU waste stored at Los Alamos National Laboratory.

The Permittees stated cause for the requested time extension is acceptable. The submittal date for the investigation report is hereby postponed from August 30, 2012 to **August 30**, 2014, as requested. NMED may re-evaluate the need for this extension based on the Permittees' progress in accelerating removal of TRU waste from TA-54 or if new information becomes available that indicates off-site migration of contamination. The Permittees must notify NMED, within 30 days of receipt of such information, should funds become available in the future that allow for the IWP to be prepared and submitted for the Twomile Canyon Aggregate Area prior to August 30, 2014.
