Dear Messrs. Maggiore and Brandt:

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Drilling Work Plan for Regional Aquifer Well R-61r* (Plan) dated February 2015 and referenced by EP2015-0015. NMED has reviewed the Plan, and hereby issues this approval with the following modification.

The Permittees propose to drill R-61r approximately 50 feet upgradient of R-61. It is NMED's opinion that 50 feet may not be an adequate distance from R-61 to avoid capturing altered and impacted groundwater at R-61. Therefore, the Permittees must drill R-61r a minimum of 300 feet upgradient or near upgradient from well R-61. Preferably, and assuming site access is attainable with respect to surface archeology, topography, etc., the R-61r drill-site would be positioned west or southwest of R-61. This location would provide adequate long-term contaminant monitoring at or near the facility boundary and be far enough from R-61 to avoid potential capture of impacted groundwater.


