Dear Ms. Armijo and Mr. Bretzke:

The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, LLC (LANS) (collectively, the Permittees) *Demolition Notification for Fiscal Year 2017 and Quarter Ending March 30, 2017* dated and received December 20, 2016, (referenced by EPC-DO-16-363, LA-UR-16-29086).

As stated by the Permittees, investigations are not complete at several Solid Waste Management Units (SWMUs) and Areas of Concern (AOCs) located within 50 feet of the buildings proposed for demolition. The Permittees state that they will ensure that the sampling locations and depths proposed in the approved work plans are not affected by these activities. In the case of adverse impacts to the SWMUs/AOCs where investigations are not complete, the Permittees must document all demolition activities that affected any SWMUs or AOCs in detail so that any impacts on work proposed at the SWMUs/AOCs can be identified and evaluated.

The Permittees must provide a copy of demolition reports, if prepared, to NMED within 30 days after the reports are complete in accordance with Permit Section 1.17.3.




