Dear Messrs. Gregory and McInroy:

The New Mexico Environment Department (NMED) has received the United States Department of Energy and Regents of the University of California (the Permittees) document *Request for Permit Modification to Module VIII of the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit, EPA ID No. NM 890010515* submitted by Department of Energy on August 5, 2005. NMED has reviewed the supporting document *Request for Permit Modification to Module VIII of the Los Alamos National Laboratory Hazardous Waste Facility Permit, July 2005* and referenced by LA-UR-05-5281.

NMED has made a determination of "Corrective Action Complete" for solid waste management units (SWMU) 21-013(d), SWMU 21-013(e) and SWMU 21-024(f) and at area of concern (AOC) C-21-015 and AOC 21-030. NMED concurs with the Permittees conclusion that above mentioned sites do not pose unacceptable risk to human health and the environment. However, if in the future any additional information becomes available that indicates that these sites may pose a risk to human health or the environment, NMED will require the Permittees to conduct corrective action at these sites.



In addition, this letter also serves as a notification that a similar determination of "Corrective Action Complete" has been made for SWMU 3-009(d) and SWMU 55-009. The Permittees were earlier notified of NMED's concurrence with no further action determination for these two SWMUs via a letter dated September 4, 2002.

The Permittees are required to obtain a Certificate of Completion from NMED pursuant to the Section III.W.3.b of the Consent Order (March 1, 2005). However, since NMED approval for no further action was obtained for these sites prior to the signing of the Consent Order, NMED is providing this letter as equivalent to the Certificate of Completion which satisfies the requirements outlined in the Section III.W.3.b of the Consent Order.
