Dear Messrs. Gregory and McInroy:

The New Mexico Environment Department (NMED) is in receipt of Department of Energy and Los Alamos National Security LLC's (the Permittees') *Request for Certificate of Completion for Area of Concern 03-001(i)*, dated September 29, 2006 and referenced by EP2006-0871.

Area of Concern (AOC) 03-001(i) consists of two inactive material and equipment storage areas located at Technical Area 03. NMED has determined that the requirements of the March 1, 2005 Consent Order (Order) have been satisfied for this site. NMED hereby issues a "Corrective Action Complete with Controls" certification of completion for AOC 03-001(i) pursuant to Section VII.E.6.b of the Order. The control, as stated in the Permittees' approved TA-03 Investigation/Remediation Report, is that the land use is restricted to industrial uses.

Per Section VII.E.6. b of the Order, "[i]f an AOC is designated as Corrective Action Complete with Controls, then the AOC shall be considered a SWMU and added to the Permit". Therefore,
