The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Revised Request for Extension to Submit the Response to the Notice of Disapproval for the Investigation Report for Cañon de Valle Aggregate Area Technical Area 14 and the Investigation Report, Revision 1* (Report) dated July 27, 2012 and referenced by EP2012-0180.

The Permittees request the extension to submit the revised Report in order to discuss the collection of soil samples for laboratory analysis of dioxins and furans, which were required by NMED's Notice of Disapproval dated June 28, 2012, so that these data could be incorporated into the site-specific risk assessments.
