



SUBJECT: SAMPLING NOTIFICATION FOR STORM EVENTS IN FY04

Dear Mr. Young:

The Los Alamos National Laboratory (LANL) Risk Reduction and Environmental Stewardship – Remediation Services (RRES-RS) program is planning to conduct storm event sampling at Potential Release Site (PRS) 16-021(c)-99. This sampling event will take place from August 18 through September 30, 2004. Surface water and ground water samples will be collected in Martin Spring Canyon and Cañon de Valle in order to comply with the Corrective Measure Study (CMS) Plan for PRS 16-021(c) and the Phase II RFI Report for PRS 16-021(c).

Samples will be collected and analyzed as outlined in the following table:


