The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security L.L.C.'s (LANS) (collectively, the Permittees) *Response to the Notice of Disapproval for the Delta Prime Site Aggregate Area Investigation Report, Revision 1* (Response), dated June 20, 2008 and referenced by LA-UR-08-3873/EP2008-0305, and the *Delta Prime Site Aggregate Area Investigation Report, Revision 1*, dated March 2008 and referenced by LA-UR-08-1834/EP2008-0062. 
