The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security L.L.C.'s (LANS) (collectively, the Permittees) *Periodic Monitoring Report for Vapor-Sampling Activities at Material Disposal Area T, Consolidated Unit 21-016(a)-99, at Technical Area 21, Third Quarter Fiscal Year 2011*, dated October 2011 and referenced by LA-UR-11-5878/EP2011-0288 (PMR). The data in the PMR indicate that volatile organic compounds and tritium continue to be present in the subsurface and may indicate the potential for future vapor intrusion to buildings or other structures.


