The New Mexico Environment Department is tentatively approving an amendment to the Resource Conservation and Recovery Act (RCRA) Permit Closure Plan to Los Alamos National Laboratory (LANL). The effect of the amendment will be to allow LANL to close and dismantle the Controlled Air Incinerator as opposed to achieving RCRA Clean Closure.


