The New Mexico Environment Department (NMED) has received the above-referenced Closure Plans submitted by the University of California and the U.S. Department of Energy. NMED has determined that the Plans are administratively complete.

The New Mexico Hazardous Waste Management Fee Regulations, at 20.4.2.201.5 NMAC, require that a facility submitting a closure plan for review and approval by NMED pay a closure plan review fee in an amount equal to the sum of the closure plan review fees set forth in 20.4.2.205 NMAC, Table 2.3, for each unit included in the Closure Plan.


A fee assessment invoice will be sent to you under separate cover. Payment is due within 60 days after your receipt of the invoice. Upon receipt of the fee, NMED will initiate review of the Closure Plans in accordance with 20.4.2.201.5.2.

If you request an extension of the 60 day payment period, you must submit an extension request to NMED at least 14 days prior to the end of the 60 day period. If you disagree with the assessed fee, you may file an administrative appeal in compliance with 20.4.2.302.1 NMAC.

If you transmit the fee electronically, submit a letter in addition to Cindy Abeyta, NMED Hazardous Waste Bureau Financial & Data Management Program Manager, indicating the invoice number, payment amount, date of payment, and the assessed document.
