

Subject: Additional Information, Replacement Asphalt Pad, Technical Area 54, Area G, Los Alamos National Laboratory NM 0890010515

The purpose of this letter is to notify your office of construction scheduling changes and provide the attached construction figure for the asphalt pad to be constructed at Technical Area 54. This pad is the subject of the Change During Interim Status approval issued by your office on December 12, 2002. As we discussed by telephone on February 6, 2003, the construction schedule for the asphalt pad has been revised based upon funding availability.

The attached figure illustrates the division of the construction activities for this project into three phases. The phases represent separate asphalt placement activities but are not actual design changes to the original project as approved. Phase 1 will be started within a short period but the completion of the additional phases is dependent upon the continuing resolution of funding plans. As a result, the scheduling of subsequent phases is not resolved at this time. Further information will be provided as it develops.
