

The New Mexico Environment Department (NMED) issued a Notice of Disapproval (NOD) for the United States Department of Energy (DOE) and Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Corrective Measures Evaluation (CME) Report for Material Disposal Area (MDA) G, Solid Waste Management Unit 54-013(b)-99, at Technical Area 54, Revision 2* (Report), dated November 2010 and referenced by LA-UR-10-7868/EP2010-0507. The NOD was issued on April 1, 2011.

The date for completion of the regional aquifer well(s) generally north of MDA G was incorrectly listed as April 30, 2011. The correct date is **April 30, 2012**.
