The New Mexico Environment Department (Department) has received from the United States Department of Energy and Los Alamos National Security, LLC, (collectively, the Permittees) a *Transmittal of Class 1 Permit Modification Request to Remove Dome 224 from the Los Alamos National Laboratory Hazardous Waste Facility Permit (PMR)* and referenced by EPC-DO-16-288 and LA-UR-16-27097. The Permittees submitted this permit modification request (PMR) on October 19, 2016, seeking to modify the Permit to provide updates to the descriptions and figures to reflect removal of a structure from the permitted unit that is located at Technical Area 54 Area G, Pad 5.

NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter. Upon receipt of the payment, NMED will initiate a technical review of the submittal


