

RE: Required addendum to Revised Groundwater Plan

Dear Mr. Johnson:

The New Mexico Environment Department (NMED) received your submittal of the Revised Groundwater Assessment Plan on January 17, 1992. This submittal was a response to Corrective Action Directive NMT360010342 issued to Public Service Company Of New Mexico (PNM) by NMED September 18, 1992. The plan is adequate to begin the work schedule at the site; however, certain items required by the NMED technical schedule were not included or need to be ltered. PNM must submit an addendum to this proposal which will include:

- 1) A commitment to complete Phase I, Items 2.A.1 through 2.A.5 as part of the Assessment Summary Report prescribed in Phase I, Item 8.
- 2) A completed Phase I, Item 2.H. 2.I, and 2.N
- 3) Phase I, Item 5 must be changed to say "The schedule in Phase One, Item 2.L is triggered January 29, 1992. Quarterly sampling of the assessment wells will continue while assessment program is in effect."

This letter constitutes approval to begin the assessment work at the site and the technical schedule need not be interrupted. The addendum must be received by NMED on or before January 31, 1992. Approval of the Groundwater Assessment Plan will be granted when this addendum is received.
