Dear Mr. Hunt:

I am writing to you on behalf of Governor King to provide the status of investigative and regulatory activities at the Public Service Company of New Mexico's San Juan Generating Station and Shumway Arroyo. It is my understanding that you asked the Governor a number of questions regarding this site during a town meeting in Farmington. My apologies for the amount of time it has taken to prepare this response, which has required inquiries of many sections within the Environment Department and the U. S. Environmental Protection Agency (EPA).

EPA, through its Superfund Program, investigated the site in 1987 and 1988. The results of these investigations indicated a possible release of hazardous substances. The EPA Superfund Program then deferred the site to the EPA RCRA Program for possible corrective action. We are currently trying to determine if EPA's RCRA Program has evaluated the site, as indicated in the attached letter to Allyn Davis of EPA.

The Environment Department is currently regulating the San Juan Generating Station through six active ground-water discharge plans. It is the intent of these regulatory activities to prohibit future releases of materials to the environment which would adversely affect human health or the environment. The San Juan Generating Station is not regulated under the state's hazardous waste program; however, the facility is inspected by staff of this program on a periodic basis.

I spoke with Michael Burkhart, Secretary of the New Mexico Department of Health, regarding your questions about the health of your children and health warnings. Mr. Burkhart advises that you consult first with your family physician regarding your children's R. G. Hunt Page 2 June 22, 1993

Dear Allyn:

The New Mexico Environment Department has received several inquiries in the past few years regarding the status of regulatory activities at PNM's San Juan Generating Station and nearby Shumway Arroyo. Recently, Governor King was asked similar questions during a town hall meeting. In order to more satisfactorily answer these inquiries, we request your assistance.

Our understanding of the history of investigations at the site is that a Superfund Site Identification form was completed for the PNM - San Juan Generating Station (also known as Shumway Arroyo or Fruitland Dairy) in April 1985, a Superfund Preliminary Assessment was completed in April 1987, a Superfund Site Inspection was completed in September 1988, and a sampling visit was conducted by FIT in October 1988. The U.S. EPA Superfund Site Assessment Section deferred the site to the RCRA Enforcement Branch on July 26, 1989 for possible corrective action. The reason for this deferral was the conclusion that "there may have been a release of hazardous waste to the environment from a RCRA regulated facility [PNM San Juan Generating Station] which may require correction [sic] action under 3008 (h)".


To the best of our knowledge, this site has not been evaluated, investigated, or cleaned up since this deferral by either state or federal Superfund or RCRA programs.
