The New Mexico Environment Department (NMED) has reviewed for administrative completeness the Public Service Company of New Mexico Post-Closure Care Permit renewal application dated June 2007 with revisions dated May 2009, as required under the New Mexico Hazardous Waste Management Regulations 20.4.1 NMAC. The application is for the renewal of the Post-Closure Care Permit for the Persons Generating Station that had been permitted under the RCRA hazardous waste treatment permit issued by NMED on August 16, 2000.

After reviewing the permit application and related documents, NMED has determined the subject application to be administratively and technically complete and adequate.

However, should any further questions arise after the public comment period, NMED may request additional information, when necessary to clarify, modify, or supplement previously submitted information.

The New Mexico Hazardous Waste Management Fee Regulations 20.4.2 NMAC require assessment of fees when administrative review of a document is complete. NMED will issue an invoice to you under a separate cover. Payment of the fees is due within sixty (60) calendar days from the date that you receive the invoice.

Should PNM need to request an extension of the sixty-day period, the request must be received by NMED a minimum of fourteen (14) calendar days prior to the end of the sixty-day period. Should the Permit Applicant disagree with the fee assessed you may file an Administrative Appeal under the provisions of 20.4.2.302.1.NMAC. Upon receipt of the fee NMED will issue the draft Post-Closure Care Permit for comments.
