

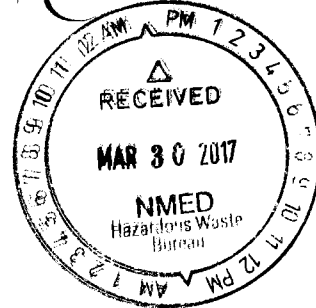

**Report of Independent Registered Public Accounting Firm
on Applying Agreed-upon Procedures**

The Board of Directors and Stockholders
Public Service Company of New Mexico:

We have performed the procedures included in the Code of Federal Regulations (CFR) Title 40, Part 264, Section 145 (40 CFR 264.145), which were agreed to by the New Mexico Environment Department Hazardous Waste Bureau and Public Service Company of New Mexico and subsidiaries (the Company), solely to assist the specified parties in evaluating the Company's compliance with the financial test option as of December 31, 2016, included in the accompanying letter dated March 27, 2017 from Charles N. Eldred, Executive Vice President and Chief Financial Officer of the Company. Management is responsible for the Company's compliance with those requirements. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants, as adopted by the Public Company Accounting Oversight Board. The sufficiency of these procedures is solely the responsibility of those parties specified in this report. Consequently, we make no representations regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

The procedures that we performed and related findings are as follows:

We recomputed the amount included in item 5 under the caption Alternative II, Tangible net worth, in the letter referred to above, as the line item entitled "Total PNM common stockholder's equity" in the amount of \$1,397,871,503 less the line item entitled "Goodwill" in the amount of \$51,632,295 of pages B-21 and B-20, respectively, in the audited consolidated financial statements of the Company as of and for the year ended December 31, 2016 as filed with the Securities and Exchange Commission on Form 10-K, on which we have issued our report dated February 28, 2017, and noted no difference. It should be understood that (1) we make no representations regarding the Company's determination and presentation of the non-GAAP measure of tangible net worth and (2) the non-GAAP measure presented may not be comparable to similarly titled measures reported by other companies.

We recomputed from, or reconciled to, the audited consolidated financial statements of the Company as of and for the year ended December 31, 2016, the information included in items 6 and 9, under the caption Alternative II, in the letter referred to above and noted no differences.

We were not engaged to, and did not, conduct an examination, the objective of which would be the expression of an opinion on the elements, accounts, or items of a financial statement. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
