
Under the provisions of 20.4.2.302.1 NMAC “[a]n invoice for fees may be appealed by filing a written request for hearing with the Hearing Clerk designated by the Secretary of Environment within thirty (30) days of the date of the invoice. The written request shall be accompanied by a copy of the invoice being contested and shall set forth the grounds upon which the appellant disagrees with the assessment.”
