SUBJECT: Quarterly Progress Report

Dear Mr. McDonald:

In compliance with Philips Semiconductors' HSWA permit (NMD000709782-1), modified March 18, 1996, this letter serves as the quarterly progress report as required. The following progress has been made between September 17, 2003 and December 12, 2003.

- *D.1(a) - A description of the work completed and an estimate of the percentage of work completed:* Quarterly groundwater monitoring was completed on October 6, 2003. Five (5) monitoring wells were sampled this quarter, which included City of Albuquerque wells NCLF-7 through NCLF-9, and Philips wells MW-5 and MW-6.
- *D.1(b) - Summaries of all findings, including summaries of laboratory data:* A quarterly groundwater monitoring report (Sangre De Cristo Sciences; December 4, 2003) is included with this report for your files.
- *D.1(c) - Summaries of all problems or potential problems encountered during the reporting period and actions taken to rectify problems:* No problems identified.
- *D.1(d) - Projected work for the next reporting period:* Quarterly groundwater monitoring will continue. All Philips wells are now on annual monitoring frequency due to 8 or more quarters of Tetrachloroethylene concentration below 10 ppb. This change is in accordance with the Class I Permit Modification issued by NMED to Philips Semiconductors on January 6, 2000. Philips Semiconductors will continue to sample wells quarterly for Tetrachlorethylene.
- *D.1(e) - Summaries of contacts pertaining to corrective action or environmental matters with representatives of the local community, public interest groups or State government during the reporting period:* No contact or communication made this quarter.
- *D.1(f) - Changes in key project personnel during the reporting period:* No Changes.
- *D.1(g) - Summaries of all changes made in implementation during the reporting period:* No Changes.
