This letter notifies you of a final permit decision by the New Mexico Environment Department (NMED) to modify Module IV of the Resource Conservation and Recovery Act (RCRA) Permit NMD9570024423 issued to Philips Semiconductors (PSC). PSC requested this modification on October 27, 2005. The modification consists of the approval of No Further Action (NFA) status for one Solid Waste Management Unit (SWMU #8, the former Coronado Municipal Landfill) located at PSC in Albuquerque, New Mexico. The modification is effective thirty days after the date of this letter. SWMU #8 is the only SWMU listed on HSWA Corrective Action module of PSC's RCRA Permit. Therefore, this approval also results in the termination of the HSWA Corrective Action Module of PSC's RCRA Permit.

In accordance with 20.4.1 NMAC, NMED provided public notice and conducted a 45-day public comment period from December 29, 2005, through February 13, 2006, regarding this modification request. No comments were received from the public during the comment period.
