Dear Ms. Huff:

The New Mexico Environment Department has completed a Class Determination of the three (3) Permit Modifications that were requested for the Safety-Kleen Farmington Facility (EPA # NMD980698849). All three (3) Modifications listed below are Class I Permit Modifications under the provisions of 40 CFR § 270.42 Appendix I section B.6.d.

1. Change in the Emergency Information sheet required in Attachment II-6-4 (Contingency Plan) of the Permit. Information changed is telephone number for 24 hour pager contact of Emergency Coordinator and Alternate Emergency Coordinator.
2. Change in the language of Permit Condition II.E.7 to allow informal informational updates according to a submittal schedule agreed upon between NMED and Safety-Kleen Corporation.

NMED requests that Safety-Kleen use the following language to modify Condition II.E.7:

Safety-Kleen Farmington Facility will submit to NMED on the last working day of March and the last working day of September for each year this permit is in effect any of the following forms and information that has changed:

- Telephone Numbers
- Mailing Address (without physical change in location)
- Emergency Coordinator information
- Alternate Emergency Coordinator information
- Signatory Authority changes
- Any forms that may be effected by any of the above informational changes

Should there be no informational changes made during the reporting period no report need be filed.


3. Request to change the name "mineral spirits" throughout the permit be changed to "parts washer solution".

Within thirty (30) working days of the receipt of this letter Safety-Kleen must submit to NMED the following:

1. Permit Modification Fee of \$1,000 for the Class I Permit Modifications listed above.
2. Redline/Strikeout version of the pages to be modified.
3. Clean Copy version of the pages to be modified with the new language incorporated.
4. A software copy of numbers 2 and 3 above. Software copy must include all pages of the section (module or attachment) being modified. Should Safety-Kleen need further guidance in how to produce this software copy they need to contact the Permit Writer.
5. Within seven (7) working days of the submittal of materials in 1 through 4 above Safety-Kleen will mail to each person on their mailing list a detailed description and location of the modifications made to the permit. Mailings for Safety Kleen Albuquerque may be included in the same mailing because they are in the same district and have the same mailing list.
