Dear Mr. Wolfe:

The New Mexico Environment Department (NMED) has completed the Final Annual Audit for calendar year 2001 for your facility. Enclosed are the Annual Unit Audit Tables for *only* those units that will be billed, developed as a result of the draft Annual Unit Audit, and an invoice for the Annual Hazardous Waste Management Business Fee (HWMBF). The tables are formatted accordingly: 1) Table A includes all operating, closure, and post-closure care units, 2) Table B includes corrective action units (e.g. SWMUs), and 3) Table C is the summary of all billable units.

If your facility has operating unit(s), that did not manage hazardous waste for the entire 2001 calendar year, an affidavit must be provided to NMED affirming no such activity. The NMED will then not bill for the unit on the 2001 HWMBF.

Under the provisions of 20.4.2.301.1 NMAC "Payment shall be due within sixty (60) days of receipt of the invoice unless the facility submits to NMED a written request and receives written approval to extend the time for payment before the date payment is due." Should the Return Receipt Request card attached to this letter be returned without a date of receipt the fee is due within sixty (60) days of the date of this letter.

Should your facility find it necessary to appeal the Annual Fee invoice under the provisions of 20.4.2.302 NMAC the appeal must be filed within thirty (30) days of the date of the invoice accompanying this letter. Any appeal of the HWMBF invoice must be filed in writing and accompanied by a copy of the invoice being contested and state the grounds upon which the appellant disagrees with the assessment.


