HAZARDOUS WASTE FACILITY CERTIFICATE OF LIABILITY INSURANCE

1. Great American Insurance Company, the Insurer, of 301 E 4th St, Cincinnati, OH 45202, hereby certifies that it has issued liability insurance covering bodily injury and property damage to Safety-Kleen Systems, Inc., the Insured, of 42 Longwater Drive, Norwell, MA 02061 (address) in connection with the Insured's obligation to demonstrate financial responsibility under the New Mexico Hazardous Waste Management Regulations, Section 20.40.1.500. The coverage applies at EPA ID# SEE ATTACHED LIST, for sudden accidental occurrences. The limits of liability are \$1,000,000 each occurrence and \$2,000,000 annual aggregate, exclusive of legal defense costs. The coverage is provided under policy number PRE E603235 01 issued on November 1, 2021. The effective date of said policy is November 1, 2021.

2. The Insurer further certifies the following with respect to the insurance described in Paragraph 1:
 - (a) Bankruptcy or insolvency of the Insured shall not relieve the Insurer of its obligations under the Policy.

 - (b) The Insurer is liable for the payment of amounts within any deductible applicable to the policy, with a right of reimbursement by the Insured for any such payment made by the Insurer. This provision does not apply with respect to that amount of any deductible for which coverage is demonstrated in the New Mexico Hazardous Waste Management Regulations, Section 20.40.1.500.

 - (c) Whenever requested by the New Mexico Environment Department, the Insurer agrees to furnish to Secretary a signed duplicate original of the policy and all endorsements.

 - (d) Cancellation of the insurance, whether by the Insurer, the Insured, a parent corporation providing insurance coverage for its subsidiary, or by a firm having an insurable interest in and obtaining liability insurance on behalf of the owner or operator of the hazardous waste management facility, will be effective only upon written notice and only after the expiration of sixty (60) days after a copy of such written notice is received by the Secretary of the New Mexico Environment Department.

 - (e) Any other termination of the insurance will be effective only upon written notice and only after the expiration of thirty (30) days after a copy of such written notice is received by the Secretary of the New Mexico Environment Department.

I hereby certify that the wording of this instrument is identical to the wording specified in the New Mexico Waste Management Regulations, 20.40.1.500, incorporating by reference of 40 CFR 265.151(j) as such regulation was constituted on the date first above written, and that the Insurer is licensed to transact the business of insurance, or eligible to provide insurance as an excess or surplus lines insurer, in one or more States.
