On behalf of the U.S. Department of Energy/National Nuclear Security Administration (DOE/NNSA) and Sandia Corporation (Sandia), DOE/NNSA is notifying you that we anticipate executing the Mixed Waste Landfill (MWL) Corrective Measures Implementation Plan (CMIP) beginning on May 14, 2009. Contracting was completed in late March and mobilization to the field is expected in early May, after Sandia's approval of the Contract-Specific Safety Plan. DOE/NNSA and Sandia will adhere to the overall construction schedule originally proposed in the December 15, 2006 Notice of Deficiency Comment Response on the MWL CMIP and approved as condition 1.f. in the New Mexico Environment Department conditional approval letter for the MWL CMIP dated December 22, 2008.


