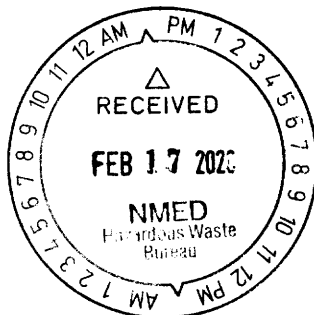

National Technology & Engineering Solutions of Sandia, LLC (NTESS) is providing the following information regarding signatories to permit applications and reports submitted under the New Mexico Hazardous Waste Act (NMHWA) and Title 20 of the New Mexico Administrative Code, Chapter 4, Part 1, Subpart IX (20.4.1.900 NMAC) incorporating Title 40 of the Code of Federal Regulations, Part 270.11 (40 CFR 270.11).

NTESS manages and operates Sandia National Laboratories (SNL). The U.S. Department of Energy, National Nuclear Security Administration (DOE/NNSA) is the owner of SNL.

Permit applications and reports submitted under 20.4.1.900 NMAC/40 CFR 270.11 for SNL are currently signed and will continue to be signed by persons who meet the requirements in 40 CFR 270.11. These include the following:

- Applications for permits and modifications to permits for hazardous waste management at SNL.
- Plans, reports, and other correspondence required by current and future hazardous waste regulations and permits, and other information requested by the New Mexico Environment Department Hazardous Waste Bureau.

- Plans, reports, and other correspondence regarding the Federal Facilities Compliance Order (FFCO) (October 1995, as amended).
- Plans, reports, and other correspondence regarding the Compliance Order on Consent (COOC) (April 2004) pursuant to the NMHWA.

As required by 40 CFR 270.11, the permit applications and reports will be signed for NTESS by one of the persons listed below.

- A Director, or individual assigned as Acting Director, responsible for environmental protection and/or waste management operations at the SNL facility in Albuquerque, New Mexico. This person meets the definition of a responsible corporate officer in 40 CFR 270.11(a)(1)(i).
- A duly authorized representative reporting to the Director or Acting Director responsible for environmental protection and/or waste management operations at the SNL facility in Albuquerque, New Mexico. This person meets the definition of a delegated manager in 40 CFR 270.11(b)(2).
