Carl -

This morning, I partook in a call with you and David Cobrain, also of NMED. Here are the notes regarding the items you and your colleagues identified during the review of the documentation received from ERM. Please let me know if any of this is inconsistent with your intended meaning.

1. You indicated that you would like to see a bid for the installation of the on-site containment system. *specifications and*
2. You indicated that you would like to see specifications and a bid for the modification to the SVE system.
3. You indicated that you would like to see cost information for the permits, including the renewal of the permit for RCRA, the permits for this year's activities, the ground water discharge permit, and the air permit.
4. You indicated that you would like to see cost information for the periodic abandonment of wells due to the fluctuation of the ground water table.
5. You indicated the preparation of a Health and Safety Plan may not be required under the Work Plan. *COST OF H+S IF NECESSARY.*
6. You indicated that you would like to see drilling costs for Well 72, as indicated in the Work Plan.
7. You indicated that you would like to see cost information for the sampling of Well 72 and the report that may possibly be produced. *IF NECESSARY*
8. You indicated that you would like to see additional information on the specific activities to be undertaken for the on-site and off-site monitoring.

9. You indicated that you would like additional detailed information outlining what activities will be conducted in the on-site and off-site monitoring. You indicated you would like to see additional information that will enable you to assess how we arrived at the cost listed on the cost table for the on-site and off-site monitoring.
10. You indicated that you would like additional information as to how long the SVE system will operate. BASIS FOR 5 YRS. + MODIFICATION COSTS.
11. ~~You indicated that a representative from Metrix mentioned that the infiltration galleries were only good for four (4) years.~~ You indicated that you would like to see additional information on the maintenance of these infiltration galleries and the associated costs.
12. You indicated that you would like to see cost information on the maintenance of the infiltration ponds.
13. You indicated that you would like to see the addition of costs associated with the closure of the system. Specifically, you indicated that there ^{may} ~~would~~ need to be backfilling of the infiltration ponds and infiltration galleries, soil sampling for the sediments in the infiltration galleries, and dismantling of structures.
