E. Offsite-Containment System

The system ran 99.8% of the time and pumped 9,732,800 gallons (average of 225.1 gpm). One outage occurred: On June 23rd for 1.62 hours. The cause was unknown but thought to be an intermittent power failure that caused a relay to open.

F. Source Containment System

- The system ran 98.4% of the time and pumped 2,012,730 gallons (average of 46.6 gpm). 2 Outages occurred: One on 6/13 for 1.08 hours. This was a trouble shooting session on the pump. The second was on 6/29 for 10.35 hours to enable the replacement of the submersible pump. It had been determined the 3hp pump had worn excessively, and it was replaced with a 5hp pump.
