Dear Addressees:

Pursuant to Paragraph 90 of the above-referenced Consent Decree, Sparton Technology, Inc. ("Sparton") is to submit assurance of its financial ability to complete work required by the Consent Decree. Since entry of the Consent Decree, Sparton has satisfied that requirement through its parent, Sparton Corporation, meeting certain financial tests. Sparton had anticipated submitting a similar assurance on or before September 30 of this year.


Unfortunately, on September 15, 2009, at the completion of the audit for Sparton Corporation's last fiscal year it became apparent, as a result of several one time events, that the financial results for its last fiscal year would prevent Sparton from providing financial assurance as it has in the past.

Pursuant to Paragraph 95 of the Consent Decree, Sparton has 30 days from September 15, 2009, to obtain and submit to EPA and NMED alternate financial assurance. Sparton has been working diligently to obtain that financial assurance and hoped to have it by today. Unfortunately, it needs to provide additional analysis to obtain the necessary alternatives. Sparton anticipates that it will have the alternate financial assurance on or before the deadline called for under Paragraph 95 of the Consent Decree, October 15, 2009.
