The Environmental Protection Agency (EPA) and the New Mexico Environment Department (NMED) reviewed the 2010 Financial Assurance documents submitted by Sparton Corporation for the Sparton Technology, Inc. facility on 9621 Coors Rd. NE, Albuquerque, NM in a letter dated September 20, 2010. EPA and NMED in a letter dated January 28, 2011 required clarification on several questions regarding the submittal. In a letter dated March 2, 2011, Sparton adequately addressed three of the four questions regarding the submittal.

In a letter dated March 29, 2011, EPA and NMED requested further clarification on the Corporate Guarantee for Closure and Post-Closure Care submitted by Sparton on September 20, 2010. Sparton revised the Guarantee on April 26, 2011 and submitted the revised Guarantee to EPA and NMED in a letter dated May 9, 2011. The revised Guarantee is deemed adequate. The 2010 Financial Assurance documents as revised are hereby approved.
