MONTHLY PROGRESS REPORT For month ending August 31st, 2015

Tasks Completed:

A. Groundwater Monitoring Plan

- Continued to evaluate Monitoring Wells replacement needs.
- The 3rd Quarter 2015 round of water-level and water-quality monitoring was conducted between August 3-6, and August 3-13, respectively.
 - B. Public Involvement Plan
 - C. Deep Flow Zone System

D. Assessment of Aquifer Restoration

 The 2014 Annual Report was approved by the the EPA and NMED on August 28, 2015.

E. Offsite-Containment System

- The system ran 87.86 % of the time and pumped 10,112,900 gallons (an average of 250.4 gpm). There were two outages totaling 81 hours 52 minutes.
 - o The outage on 8/14/15 through to 8/17/15 for 81 hours 30 minutes was due to a power outage. Additionally, the outage was extended on the 17th because the discharge sump pump was unable to keep up with the system flow.
 - On 8/26/15 the system was taken down for 22 minutes for routine sump maintenance.

F. Source Containment System

- Continued weekly chromium sampling of (a) the influent to the first tank of the chromium removal system; (b) the effluent from the second tank; and (c) the effluent from the air-stripper. All samples of the effluent from the air-stripper were below the NMWQCC chromium standard of 0.050 mg/L.
- The system ran 97.2 % of the time and pumped 1,958,200 gallons (an average of 48.5 gpm). There were two outages totaling 18 hours 40 minutes.
 - There was a tank and filter exchange outage on 8/17/15 totaling 20 minutes.
 - A power outage occurred 8/17 to 8/18 for 18 hours 20 minutes.
