**RE: Disclosure Forms for the Triassic Park Hazardous Waste  
Disposal Facility in New Mexico**

Dear Mr. Newell:

The Hazardous and Radioactive Materials Bureau (HRMB) of the New Mexico Environment Department has reviewed the Disclosure Forms, sent by you on August 28, 1996, for the Triassic Park Disposal Facility. The Disclosure Forms are required of every applicant for a permit pursuant to the New Mexico Hazardous Waste Act. HRMB has determined the information provided on the forms is deficient; therefore the forms are being returned to you with this letter.

The instructions provided with the various Disclosure Forms direct that "ALL QUESTIONS MUST BE ANSWERED". Examples of the deficiencies are the *Main Disclosure Form* (item #11 left blank) and the *Personal History Disclosure Form* for Mr. H. Dale Gandy (items left unanswered on pages 3, 4, 9, and 12). An additional copy of the instructions pages for the *Main Disclosure Form* and *Personal History Disclosure Form* is enclosed.


The *Governmental Agency Disclosure Statement* you sent, along with its *Subsidiary Disclosure Form*, is not needed since Triassic Park will be a private enterprise. In its place a *Business Concern (Governmental Entity) Disclosure Statement* should have been submitted. A copy of this form is enclosed. Please complete and return it to HRMB.

In summary, the *Main Disclosure Form, Listed Business Concern Disclosure Form, Business Concern (Governmental Entity) Disclosure Form, and Personal History Disclosure Forms* should be completed, following the instructions provided with the forms, and returned to this office. Any attachments to the forms should be numbered and referred to in the form. Also, you may wish to stamp each page "CONFIDENTIAL".

Please provide this information within ten (10) days of receipt of this letter in order to expedite processing of this application.
