RE: Request for Document Comparison Meeting

Dear Mr. Gandy:

The Hazardous and Radioactive Materials Bureau (HRMB) of the New Mexico Environment Department (NMED) has completed a review of your company's June 3, 1997 response to comments sent to your office on March 21, 1997. The approach in this response appears to be acceptable, however, there are still gaps in information presented that raise regulatory concern and prevent approval of the June 3, 1997 response. Based on HRMB's Administrative Record as compared to citations by your consultants as to what your company states has been submitted HRMB believes that HRMB staff and your consultants are using two similar but different documents to work from. HRMB asks that you and your staff make arrangements for a meeting ON THURS. 7/10/97 AT 1:30 PM with HRMB to do a page by page comparison of each of our documents to assure that the administrative record and your working files are the same. Once we, HRMB and you, are certain that the same document is being used to generate requests for information and respond to that information; we will be able to proceed with the application review more rapidly.

It is NMED's understanding that following the receipt of this letter TerraMatrix will begin detailed design of the facility. NMED emphasizes the design calculations and each engineering drawing must be signed and sealed by a professional engineer registered in New Mexico. The example drawing in the June 5, 1997 meeting did not meet these requirements and calculation examples were not presented. The level of detail shown on the example drawings is what is expected by NMED for the Triassic Park Facility and must be received prior to issuance of a Revised Draft Permit.
