You informed me that the NMED has reviewed the language of the Hazardous Waste Bureau permit disclosure form and interpreted the language regarding violations under any "environmental statute" to include OSHA violations. There is no definition or list of statutes that constitute an "environmental statute." There is not any regulation implementing the disclosure statute. Prior to your communication, GMI did not interpret the disclosure language to include OSHA. However, based upon information indicating the Departments interpretation of this language, GMI will provide information on OSHA. I will forward you the OSHA information in the next several days.
