Dear Mr. Gandy:

By my authority as Secretary of the New Mexico Environment Department (NMED) under 20.4.1.901.A NMAC, I hereby issue to Gandy-Marley Corporation (Permittee) a permit to manage hazardous waste in the State of New Mexico. This Permit is issued pursuant to the Resource Conservation and Recovery Act (RCRA), as amended (42 USC 6901, *et seq.*) and the New Mexico Hazardous Waste Act, Section 74-4-1 to -14 (1977). This Permit authorizes the Permittee to treat, store and dispose of hazardous waste at the Triassic Park facility. The permittee's compliance with the conditions of this Permit constitutes compliance with New Mexico's hazardous waste regulations, 20.4.1 NMAC, for treatment, storage and disposal of hazardous waste for the duration of this Permit, unless modified, suspended or revoked.

The effective date of this Permit is thirty days from the date of this letter, or April 17, 2002. Copies of the Permit will be made available to the public for viewing at the Roswell Public Library, the NMED's Hazardous Waste Bureau (HWB) in Santa Fe, and on the NMED's web page at above address and following the *Environment Department Organization-Hazardous Waste-Permits-Triassic Park* links. The HWB will at all times maintain the official version of the Permit.

## HAZARDOUS WASTE FACILITY PERMIT

Pursuant to the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act (RCRA), as amended (42 U.S.C. 6901, et seq.), and the New Mexico Hazardous Waste Act, NMSA 1978, Sections 74-4-1 et seq. (Repl. Pamp. 1993), and regulations promulgated thereunder by the New Mexico Environmental Improvement Board (codified and to be codified in the Hazardous Waste Management Regulations [20.4.1 NMAC]), a Permit is issued to the Gandy-Marley, Inc. (Permittee), to operate a hazardous waste treatment, storage and disposal facility called the Triassic Park comprising three storage units (the Drum Handling Unit, the Roll-off Container Unit, and the Liquid Wastes Storage Tanks), two treatment units (Stabilization Bins and the Surface Impoundment), and one disposal unit (Phase I Landfill). The facility is located in southeastern New Mexico, 43 miles east of the City of Roswell, 36 miles west of the Town of Tatum, and 4 miles south of Highway 380, on the eastern half of Section 18 and the western half of Section 17, T11S, R31E, encompassing 480 acres.

The Permittee shall comply with all terms and conditions of this Permit. This Permit consists of the conditions herein including those in the Attachments. Applicable provisions of regulations cited are those that are in effect on the effective date of this permit, New Mexico Hazardous Waste Management Regulations 20.4.1 NMAC (Effective June 14, 2000).

This Permit is based on the assumption that all information contained in the Permit Application and the administrative record is accurate and that the facility will be constructed and operated as specified in the application. The permit application consists of information submitted in December 1997 and supplementary technical documents.

Any inaccuracies found in the submitted information may be grounds for the termination or modification of this Permit in accordance with 20.4.1.900 NMAC (incorporating 40 CFR §270.41, §270.42, and §270.43) and for potential enforcement action.

This Permit shall become effective thirty (30) days after notice of the decision has been served on the applicants, and shall remain in effect for ten (10) years in accordance with the New Mexico Hazardous Waste Act, Section 74-4-4 unless modified, suspended or revoked under Section 74-4-4.2 or 20.4.1.900 NMAC (incorporating 40 CFR §270.41, §270.42, §270.43) or continued in accordance with 20.4.1.900 NMAC (incorporating 40 CFR §270.51), or issued for a duration that is less than the full allowable term in accordance with 20.4.1.900 NMAC (incorporating 40 CFR §270.50(c)).
