The New Mexico Environment Department (NMED) received on April 30, 2012 the *Part A and B Permit Renewal Application for the Triassic Park Waste Disposal Facility, October 17, 2011, Revision 1* - April 30, 2012 (Application). The revised Application was submitted in response to the NMED comments sent in the Administratively Incomplete Determination letter dated March 14, 2012.

NMED has determined that the Application is administratively complete in accordance with 20.4.1.900 incorporating 40 CFR 270.14. The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC require the assessment of fees after an application is deemed administratively complete. The fee invoice is attached to this letter. Upon receipt of the payment, the NMED will initiate a technical review of the submittal in accordance with 20.4.2.201.B(3) NMAC.

Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If you disagree with the fee assessed, you may notify the NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.
