

Overview of Permit Modification

This document contains a Class 1 Permit Modification Notification (PMN) to the Hazardous Waste Facility Permit (HWFP) at the Waste Isolation Pilot Plant (WIPP), Environmental Protection Agency (EPA) Identification Number NM4890139088-TSDF, hereinafter referred to as the WIPP HWFP, to update the emergency coordinator list.

This notification of permit modification is being submitted by the U.S. Department of Energy (DOE), Carlsbad Field Office (CBFO) and Westinghouse TRU Solutions, LLC (WTS), collectively referred to as the Permittees, in accordance with the WIPP HWFP, Condition I.B.1 (20.4.1.900 New Mexico Administrative Code (NMAC) incorporating 40 Code of Federal Regulations (CFR) § 270.42(a)). The PMN in this document is necessary to update the list of Emergency Coordinators. This change does not reduce the ability of the Permittees to provide continued protection to human health and the environment.

The requested modification to the WIPP HWFP and related supporting documents are provided in the following sections of the PMN. The proposed modifications to the text of the WIPP HWFP have been identified using a double underline for new information added and a ~~strikeout~~ font for information proposed for deletion. There is also a right hand /outside margin Revision Bar to assist in location of all additions or ~~strikeouts~~.

This PMN contains one item to update the list of Emergency Coordinators. This item is summarized below:

Description of the Hazardous Waste Facility Class 1 Permit Modification

Item 1

Description:

This modification will update the emergency coordinator list.

Basis:

The emergency coordinator list must be updated when changes in assigned personnel occur. This modification provides those needed amendments.

Discussion:

As required by the HWFP, changes to the emergency coordinator list must be updated as soon as possible. This modification allows that change to occur. Removal of these two individuals, who are not primary emergency coordinators, will not impact emergency operations at WIPP.
