**SUMMARY COMMENTS FOR THE WATER LEVEL MEASUREMENTS FOR THE
MONTH OF FEBRUARY 2003**

1. The WIPP Groundwater Detection Monitoring Program Plan, Attachment L section L-4c(1) requires cumulative fluctuations noted in the Detection Monitoring Program wells of more than 2 feet in the course of one year to be reported. None of the WQSP wells indicate more than 2 feet of cumulative change from February 2002 through February 2003. Interim fluctuations greater than two feet are related to specific pumping episodes.
