SUMMARY COMMENTS FOR THE WATER LEVEL MEASUREMENTS FOR THE
MONTH OF APRIL 2003

1. The WIPP Groundwater Detection Monitoring Program Plan, Attachment L, Section L-4c (1) requires cumulative fluctuations noted in the Detection Monitoring Program wells of more than two feet in the course of one year to be reported. None of the Water Quality Sampling Program wells indicate more than two feet of cumulative change from March 2002 through March 2003. Interim fluctuations greater than two feet are related to specific pumping episodes.
2. No measurement was taken at well DOE-2 due to instrumentation installed by SNL.
