

SUMMARY COMMENTS FOR THE WATER LEVEL MEASUREMENTS FOR THE
MONTH OF NOVEMBER 2003

1. The WIPP Groundwater Detection Monitoring Program Plan, Attachment L, Section L-4c (1) requires cumulative fluctuations noted in the Detection Monitoring Program wells of more than two feet in the course of one year to be reported. None of the Water Quality Sampling Program (WQSP) wells indicate more than two feet of cumulative change from December 2002 through November 2003. Interim fluctuations in the WQSP wells greater than two feet are related to specific pumping episodes.
2. Groundwater level measurements were not taken at wells DOE-2 and SNL-2 due to instrumentation installed by Sandia National Laboratories (SNL). These wells will not have water level measurements taken from them until SNL completes their well testing and removes their instrumentation.
3. Adjusted freshwater heads are based on the most current fluid density measured for each well.
