
Dear Mr. Zappe:

SUMMARY COMMENTS FOR THE WATER LEVEL MEASUREMENTS FOR THE
MONTH OF JANUARY 2005

1. The WIPP Groundwater Detection Monitoring Program Plan, Attachment L, Section L-4c (1) requires cumulative fluctuations noted in the Detection Monitoring Program wells of more than two feet in the course of one year which are not attributable to site tests or natural stabilization to be reported. None of the Water Quality Sampling Program wells indicate more than two feet of cumulative change from December 2004 through January 2005. Interim fluctuations in the Detection Monitoring Program wells greater than two feet are related to specific pumping episodes or natural stabilization.
2. Groundwater level measurements were not taken at well H-15 due to instrumentation installed by Sandia National Laboratories (SNL). Automated water level monitoring testing continues at well H-15. Water level measurements will not be taken from this well until all testing is completed and all instrumentation removed.
3. Groundwater level measurements were not taken at well SNL-2 and WIPP-30 due to SNL testing. Water level measurements will not be taken from these wells until all testing is completed and all instrumentation removed.
4. Groundwater level measurements were not taken at well WIPP-26 due to road hazards after recent rainfall. Water level measurements will not be taken until access is possible.
5. Adjusted freshwater heads are based on published fluid density data. Density values are changed from previously published data (DOE/WIPP 03-3291, *SNL 9 Basic Data Report*) for each well that has experienced a significant event such as well maintenance, sampling, development, or pumping activities.
