Enclosed is the Audit Report for the Carlsbad Field Office (CBFO) Recertification Audit A-11-10 of the Hanford Site Central Characterization Project processes performed to characterize and certify waste as required by Part 2, Section 2.3.2.3, *Final Audit Report*, of the Waste Isolation Pilot Plant Hazardous Waste Facility Permit. The audit was conducted April 5-7, 2011.

The report contains the results of the recertification audit performed for contact-handled Summary Category Group S5000 debris waste. In addition, the audit report contains the results of the initial certification audit for Summary Category Group S3000 homogeneous solid waste. The audit team also evaluated certification activities related to the high-energy real-time radiography system for characterization of standard waste boxes.
