Subject: Notification of Exceedance of a Disposal Room Volatile Organic Compound
Monitoring Action Level for Carbon Tetrachloride

Dear Mr. Kieling:

The purpose of this letter is to notify you of the receipt of validated analytical results for a volatile organic compound (VOC), carbon tetrachloride, which exceeded the 50 percent action level listed in Part 4, Table 4.6.3.2 of the Waste Isolation Pilot Plant Hazardous Waste Facility Permit (Permit).

The carbon tetrachloride values for the disposal room samples obtained from Panel 5, closed Room 7 locations 7e and 7i collected on June 28, 2011, and closed Room 6 locations 6e and 6i collected on June 29, 2011, exceeded the 50 percent action level of 4,813 parts per million by volume (ppmv) in Permit Part 4, Table 4.6.3.2. The data were validated on July 26, 2011, in accordance with Permit Attachment N, Section N-5d. On July 7, 2011, the last waste was placed in Panel 5, the last VOC samples were taken, and on July 8, 2011, sampling was terminated in Panel 5 in accordance with Permit Attachment N, Section N-3a(2).

- Room 7 Location 7e 5,969 ppmv Collected on June 28, 2011
- Room 7 Location 7i 5,826 ppmv Collected on June 28, 2011
- Room 6 Location 6e 5,370 ppmv Collected on June 29, 2011
- Room 6 Location 6i 5,582 ppmv Collected on June 29, 2011
